

WILLMAR MUNICIPAL UTILITIES COMMISSION

MEETING MINUTES – SEPTEMBER 25, 2023 11:45 AM – WMU AUDITORIUM

The Municipal Utilities Commission (MUC) met in its regular scheduled meeting on Monday, September 25, 2023, at 11:45 am in the WMU Auditorium with the following Commissioners present: Bruce DeBlieck, Shawn Mueske, Carol Laumer, John Kennedy, Patricia Elizondo, and Terrill Sieck. Absent was Commissioner Dave Baumgart.

Others present at the meeting were: General Manager John Harren, Director of Administration Janell Johnson, Finance & Office Services Supervisor Andrea Prekker, Information Systems Coordinator Mike Sangren, Executive Secretary Beth Mattheisen, City Councilmember Michael O'Brien, City Attorney Robert Scott (via teleconference), and WC Tribune Journalist Jennifer Kotila.

The meeting opened by reciting the Pledge of Allegiance. Commission President DeBlieck continued by appointing Commissioner Mueske to serve as Acting Secretary. Following the appointment, Commissioner DeBlieck asked if there were any changes to the presented agenda. There being none, a resolution to approve the consent agenda was requested. Following review and discussion, Commissioner Mueske offered a resolution to approve the consent agenda as presented. Commissioner Laumer seconded.

RESOLUTION NO. 29

The foregoing resolution was adopted by a vote of six ayes and zero nays.

Commissioner DeBlieck informed the Commission that Willmar Municipal Utilities will be commemorating Public Power Week, October 1-7, along with more than 2,000 other community-owned, not-for-profit electric utilities that provide electricity in the United States. Public power puts the people of Willmar first, and Public Power Week gives us the chance to emphasize the advantages of locally owned power to our citizens and remind them of the reliable and safe services WMU provides. Commissioner DeBlieck recited the proposed resolution and requested approval of the resolution designating Public Power Week. Commissioner Laumer offered a motion to amend the proposed verbiage. Commissioner Mueske seconded the motion which carried by a vote of six ayes and zero nays.

Following approval of the revised verbiage, Commissioner Laumer offered a resolution to approve the amended resolution designating October 1-7, 2023, as Public Power Week. Commissioner Elizondo seconded.

The foregoing resolution was adopted by a vote of six ayes and zero nays.

Commissioner DeBlieck requested the Commission to conduct a Public Hearing to proceed with the rate ordinance amendment process. Following discussion on the narrative and process involved, Commissioner Mueske offered a motion to set a Public Hearing in conjunction with the regular MUC meeting on Monday, October 9th at 11:50 am. Commissioner Kennedy seconded the motion which carried by a vote of six ayes and zero nays.

General Manager Harren informed the Commission that Staff and IBEW #160 reps met on September 20th and reached a tentative agreement and that a Labor Committee meeting will be scheduled to review the proposed union contract. In addition to this meeting, WMU Labor and Planning Committees meetings will be forthcoming. Tentative future Labor Committee agenda item(s) will include new building land acquisition and union negotiations. Tentative future Planning Committee agenda items will include new building, water treatment plant funding, new generation, and water system model.

Commissioner DeBlieck reminded Commissioners of upcoming events/dates to note:

- WMU Office lobby will be closed October 9th & 10th to allow for Staff training (software conversation).
- Renville-Sibley new facility tour (Danube): Tuesday, October 24th @ 1:00 pm
- MRES Area Meeting (Alexandria): Wednesday, October 25th @ 9:00 am

There being no further business to come before the Commission, Commissioner Mueske offered a motion to adjourn. Commissioner Kennedy seconded the motion which carried by a vote of six ayes and zero nays, and the meeting was adjourned at 12:05 pm.
